**NARRATIVE:**

SPECIMENS QB1-5 WERE COMPARED MICROSCOPICALLY WITH EACH OTHER AND TEST-FIRED SPECIMENS TB1A,B. DUE TO THE DAMAGE SUSTAINED BY SPECIMEN QB1, IT WAS INCONCLUSIVE. HOWEVER, SPECIMENS QB2-5 WERE IDENTIFIED FOR HAVING BEEN FIRED FROM THE DESCRIBED PISTOL, SPECIMEN QF1, BASED ON THE SUFFICIENT QUANTITY AND QUALITY OF MATCHING INDIVIDUAL CHARACTERISTICS IN THE RIFLING STRIATIONS.

SPECIMENS QC1-12 WERE COMPARED MICROSCOPICALLY WITH EACH OTHER AND TEST-FIRED SPECIMENS TC1A,B. THESE SPECIMENS WERE IDENTIFIED FOR HAVING BEEN FIRED IN THE DESCRIBED PISTOL, SPECIMEN QF1, BASED ON THE SUFFICIENT QUANTITY AND QUALITY OF MATCHING INDIVIDUAL CHARACTERISTICS IN THE BREECH FACE IMPRESSIONS.
